This Privacy Notice informs you of the following terms:

Fundación Avina is a not-for-profit organization, legally constituted in the region, and responsible for the processing and protection of your personal data for the purposes indicated in this Privacy Notice. You can contact **Fundación Avina** via email: privacidad@avina.net.

When you access any of the websites or portals of **Fundación Avina's** partners, you are accepting the practices described in this Privacy Notice, and give your express consent for the processing of personal information provided to the website, or provided by your entry onto this website, or by any other means. Our organization informs you that we will treat your personal information in a careful and responsible manner, employing the highest possible standards for the protection of your data and privacy.

Fundación Avina Panamá collects your personal data for the uses mentioned in this Privacy Notice. We advise you that your personal information will be processed and safeguarded on the basis of lawfulness, quality, consent, information, purpose, fidelity, proportionality, and responsibility.
