THREE OF AVINA AMERICAS' FIVE VOTING DIRECTORS HAVE SOME CONNECTION TO FUNDACION AVINA. MR. SEAN MCKAUGHAN AND MRS. HILDA VEGA SERVE ON THE BOARD OF FUNDACION AVINA, AND MRS. VALERIA SCORZA IS THE CEO OF FUNDACION AVINA. MR. SAGEL, ALTHOUGH A NON-VOTING MEMBER AS BOARD SECRETARY, IS AN EMPLOYEE OF FUNDACION AVINA. IN ADDITION, UNDER AVINA AMERICAS' CONFLICT OF INTEREST POLICY, ANY DIRECT TRANSACTION BETWEEN IT AND FUNDACION AVINA HAS TO BE APPROVED BY ALL OF THE THREE INDEPENDENT DIRECTORS WHO DO NOT HOLD ANY POSITIONS AT FUNDACION AVINA.
